and Dispensaries) IN MAINLAND TANZANIA

1. The Government of the United Republic of Tanzania through the President's Office Regional Administration and Local Government has set aside funds towards the cost of **Supply of Medicines and Medical Supplies** and it intends to apply part of the proceeds of these funds to cover the eligible payments under framework contract for **Supply of Medicines and Medical Supplies for Public Health Facilities**. The Government through **Regional Secretariats of Kagera, Mara, Tabora and Dodoma** intend to pre-qualify applicants for **Supply of Medicines and Medical Supplies**. It is expected that the invitations for tender will be made in **July, 2018**.
2. Applicants who have been pre-qualified for 5 regions need not to apply for pre-qualification in Kagera, Mara, Dodoma and Tabora regions. Moreover, those pre-qualified in less than 5 regions may apply for pre-qualification in the above stated regions to make a total of 5 regions
3. Pre-qualification will be conducted through the procedures specified in Regulation 119 of the Public Procurement Regulations (Government Notice 446) of 2013 and is open to all Applicants as defined in the Regulations.

4. Interested applicants may obtain further information and inspect the pre-qualification documents at the respective Regional Offices from 8:30 am to 3:30 pm from Monday to Friday except on public holidays.
5. A complete set of pre-qualification documents in English may be purchased by interested Applicants on the submission of a written application to **the Regional Administration Secretary, P.O.BOX 299, Musoma, the Regional Administration Secretary, Shore Road, P.O.BOX 35180, Kagera, the Regional Administration Secretary, Swetu/Airport Road, P.O.BOX 25, Tabora and the Regional Administration Secretary, Kuu Street P.O.BOX 294, Dodoma;** and upon payment of a non-refundable fee of **Tshs 150,000.00**. Payment should either be by Cash or Banker's Cheque, payable to Regional Administration Secretary.
6. All applications one original hardcopy plus three (3) hardcopies and one (1) electronic copy properly filled in and enclosed in plain envelopes must be delivered to the respective Secretary, Regional Tender Board at or before **10:00 am date of 26th June 2018**. Applications will be opened promptly thereafter in public and in the presence of Applicants' representatives who will choose to attend in the opening at the Regional Administration Secretary's Office in respective Regions.
7. Late applications, portion of applications, electronic applications, applications not received, applications not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
